CHECK-IN PROCEDURES

Campers must register at the park office. After hours or times when the park office may be closed, arrivals must check-in with the camp host. The following morning, late arrivals must check-in at the park office. Check-ins begin at 1400 hours. (2:00 pm)

CHECK-OUT PROCEDURES

Campers must vacate their sites by 1200 hours (12:00 pm) to avoid an additional day's charge. Prior to departure, it is your responsibility to police your area and deposit all trash in the proper receptacle.

RESERVATIONS

- Reservations may be made by eligible patrons only.
- Reservations are accepted: One year in advance for Active Duty military & Reservists, and 6 months in advance by all other eligible patrons.

PETS

- All guests must register their pets in the office at the time of check-in and provide written verification of their pets' current rabies vaccination.
- All pets should be under positive control by the owner at all times. Do not leave pets tied up outside.
- Pets are not permitted in the Eagle's Nest Community Center, bathroom-laundry area or park office.
- All pet droppings will immediately be picked up, bagged and properly disposed of in the dumpster.
- If a pet constitutes a danger to other guests or is found running loose, management has the authority to ask the owners to leave the campground. Do not walk pets on fellow camper sites.

CAMPGROUND RULES

- Speed limit in the park is 10 mph
- RVs may not be vacated or left unoccupied for more than 72 hours (Dec-May) and 48 hours (June-Nov) without prior management approval.
- RV units cannot be subleased or released to other personnel; the individual renting the campsite must occupy the RV.
- No external structures of any kind will be built on a site, including tents, pet cages/structures, or fencing (excepting screen rooms no larger than 10'x10').
- Smoking is not allowed in any government building or 50 feet from any entrance or doorway.

CAMPGROUND RULES (cont'd)

- Open campfires are permitted only in fire rings. Fire rings may be picked up from office/camphosts. Cutting firewood from base property is prohibited. All fires must be extinguished before retiring for the night.
- Parents/Legal Guardians/Sponsors are responsible for the safety and behavior of their family members under the age of 18 and all guests. An adult sponsor must accompany children under 10 years of age at all times. This includes the bathhouse/laundry room/restrooms.
- Appliances, other than those designed for the RV, are prohibited. Clotheslines and in-ground gardens are prohibited.
- One RV unit, 2 vehicles and no more than 1 motorcycle or golf cart are permitted per site. Any trailers will be stored in the designated storage area.
- RV sites are not to be used for commercial ventures.
- Outside personal items must remain on the concrete pad. No such items may be placed on grass area.
- Nothing on sites may detract from aesthetics of the park.
- Overflow sites share water & electric. Preference goes to the patron on the concrete pad.
- Quiet hours in the RV Park are 2200 (10:00 pm) to 0700 (7:00 am). The use of generators and noisy equipment are not permitted during quiet hours. Radios, stereos/TV volume should be kept low enough so as not to disturb your neighbors.
- Maintenance of any type is not permitted within the park. This includes washing of vehicles. You may use a bucket of water & sponge to clean vehicles; no hoses permitted.
- Occupants must adhere to all SUBBASE FORCE PROTECTION LEVELS AND HURRICANE LEVELS. All residents of the RV Park will be notified of any pending level changes that may direct an evacuation. If in case of Tornado Warnings, please seek shelter in the Community Center. Pets will be allowed in Community Center during Tornado Warnings.
- Firearms are NOT permitted onboard Naval Submarine Base Kings Bay. If you are found to be in possession of any firearms while staying at the RV Park, you will be held accountable and will be removed from the RV Park.
- Naval Submarine Base Kings Bay's Morale, Welfare and Recreation Department (MWR) and all agents of MWR and the Department of the Navy assume no responsibility for accidents or loss of personal property.

The following items are NOT allowed in trash receptacles or dumpsters.
